### **Making a booking**

## **Course Rescheduling - Applicable to all In-house courses**

**If you need to reschedule your course after we have received your booking form, the following charges will apply:**

More than 4 weeks prior to the start date of the course	£200 for each day that is changed
Between 4 and 2 weeks prior to the start date of the course	£300 for each day that is changed
Within 2 weeks of the start date of the course	100% of the total course Fee

Please note:

- Where you are changing a date you must re-booked within 3 months of the initial course date.
- **Only one change of date will be permitted.**
- We cannot guarantee that we will be able to deliver your training on the rescheduled day that you have requested, this will depend upon our trainers' availability.
- Once the 3 months period has elapsed the full fee is due and your course will not go ahead.
- We reserve the right to reschedule your course to a different date with all changes made within 4 weeks.
- If we have to cancel your new course date, you will not receive a refund for your course, but you will be offered an alternative date.

## **Cancellation Policy**
